### 3. Actions to Correct Previous Deficiencies

---

**No deficiencies were found** in previous reviews. However, the following concerns raised by the program evaluator in the previous visit have been addressed:

“Additional opportunities for students more interested in computer science than computer engineering to select electives in the area of emphasis would appear to be a useful and welcomed addition to the course offerings.” The following elective courses were added to the curriculum: “Object-Oriented Design,” “Human Interface Programming,” “Introduction to Scientific Computing,” “Computer Network Administration,” “Geographical Information Systems.”
